Healthcare workers face a wide range of workplace hazards, including ergonomic and needlestick injuries, exposures to chemicals and hazardous drugs, radiation, airborne diseases, latex allergy, needlesticks, and violence in the workplace.

The goal of the New Jersey Work Environment Council's (WEC) *Safe Work, Safe Care* Project is to create and maintain safe, healthy work environments for healthcare workers and patients. *Safe Work, Safe Care* promotes workers and managers working together, and stresses the valuable role of joint labor/management health and safety committees that rely on group problem-solving strategies to identify, analyze and reduce and/or eliminate hazards.

Safe Work, Safe Care encourages healthcare facilities to use a "systems" approach to health and safety that is supported by comprehensive reporting of injuries, efficient and thorough follow-up, and consistent program evaluation.

Safe Work, Safe Care provides quality, participatory training using a methodology that improves the problem solving and critical thinking skills of participants.
